The signer(s) is/are personally, jointly and severally, liable for any damage resulting from the falsity of a warranted fact or from his/her/their lack of authority and agrees to hold Nye County Crematory harmless from any liability on account of said authorization and cremation (NRS 454.23). He/She/They also, jointly and severally, assume full responsibility and liability for any damages incurred in the event any atomic or nuclear pacemakers have not been removed from the deceased prior to the cremation (NRS 454.118). Due to manufacturer's regulations and guidelines, Nye County Crematory cannot cremate a deceased human body in excess of 280 lbs. without use of a special cremation pan. There is an additional expense for this pan. The signer also understands that cremation destroys DNA and no DNA can be retrieved after the cremation process has been started/completed.
